### DRIVEN BY RESILIENCE: HOW ONE INDIVIDUAL ROSE TO SUCCESS



After losing her job in 2016, single mother Jennifer found herself unhoused and separated from her children. Instead of giving up, she took a bold step by enrolling in the Automotive Service Technology program at Miami Lakes Educational Center & Technical College. With the support of her instructor, Mr. Sanchez, Jennifer not only gained hands-on technical skills, but also rediscovered her confidence and drive.

She graduated from Miami Lakes in 2018, continued her education at Broward College, and earned a degree in Automotive Service Management, all while working as a tire technician and living out of her car. Despite the challenges, Jennifer persevered. In 2020, she completed a competitive training program with Tesla and was offered a full-time position in Jacksonville. Taking the job meant making the most difficult decision of her life; moving away from her children, who remained in South Florida to finish high school. For two years, Jennifer made the long monthly drive to visit them while working full-time and adjusting to a new city where she had no family or friends.





She later joined Century Ambulance, where she rebuilt 10 ambulances and completed dozens of major engine and transmission repairs. By 2024, Jennifer had earned all eight Automotive Service Excellence (ASE) certifications, a nationally recognized standard of excellence in automotive repair. That same year, she launched her own business, SOS Mobile Fleet Service LLC, a femaleowned mobile repair company. In 2025, she was promoted to Fleet Manager at Century Ambulance's new West Palm Beach location.

Jennifer's journey highlights the life-changing power of career and technical education, and the unshakable determination of a woman who sacrificed, persevered, and rose above the odds. to build a life she could be proud of.



When Javy Cardenas first spoke with Braulio Trejo, instructor at the Warren Henry Automotive Service Training Program offered in South Dade, through Miami Lakes Educational Center and Technical College, he didn't know what to expect. In fact, he'll tell you he didn't even know the difference between metric and standard tools. However, what Javy lacked in experience, he more than made up for with determination. Today, that determination has earned him the prestigious title of Student of the Year.

Javy saw an opportunity to build a better future, learning there would be no tuition cost, he pursued the opportunity. "I just wanted to find a rewarding career," he said. What he found was not only a passion for automotive technology, but a newfound confidence that's transformed his life.

Since starting the program, Javy has earned three Automotive Service Excellence (ASE) certifications, a remarkable accomplishment for someone who once had zero experience in automotive service. Now, he doesn't just assist in diagnosing vehicle problems, Javy often helps experienced technicians troubleshoot issues, demonstrating a skill set and intuition that have quickly set him apart from his peers.



"I've learned so much," Javy shared. "Now, when something is not working on a car or anything mechanical, I don't hesitate to take it apart and figure it out. That's something I never thought I'd be able to do."

Javy's story is a shining example of what's possible when opportunity meets hard work. He's not just good with cars—he's become a confident, capable problem solver, and a true inspiration to his peers. ### A NEW PATH TO STUDENT SUCCESS AT AMERICAN ADULT & CONTINUING EDUCATION CENTER




